During the financial year ended 31 March 2026, this authority's internal auditor acting independently and on the basis of an assessment of risk, carried out a selective assessment of compliance with the relevant procedures and controls in operation and obtained appropriate evidence from the authority.

The internal audit for 2025/26 has been carried out in accordance with this authority's needs and planned coverage. On the basis of the findings in the areas examined, the internal audit conclusions are summarised in this table. Set out below are the objectives of internal control and alongside are the internal audit conclusions on whether, in all significant respects, the control objectives were being achieved throughout the financial year to a standard adequate to meet the needs of this authority.

**Addendum to Little Hoole Parish Council Annual Audit Report AGAR Submission  
2025/26.**

The Annual Governance and Accountability Return (AGAR) 2025/26 requires that if the Internal Auditor has ticked “No” in the Annual Internal Audit Report then any implications must be stated and what action has been taken to address any weakness in control identified.

In the case of Little Hoole Parish Council the Internal Auditor has ticked “No” for items L and N above. The Internal Auditor commented *“The Council has published most of the required information on its website. However, the External Auditor Report and Certificate were not available at the time of review, meaning I am unable to give a positive assertion for this area. This is a minor omission in the context of otherwise strong compliance.”* This was an oversight by the Clerk; the External Auditor Report and Certificate for 2024/25, giving the Parish Council a “clean bill of health”, is now available to see on the Parish Council’s website.

The Internal Auditor’s response as “Not Covered” for item F, is due to the fact that, as per the Internal Auditor’s Report, *“No cash payments are made, which is good practice.”*

The Internal Auditor’s response as “Not Covered” for item K, is due to the fact that, the Parish Council did not exempt itself from a limited assurance review in 2024/25, but was subject to a limited assurance review.
